According to § 14 in connection with § 6 of the CoronaVO as well as § 4 para. 1 of the CoronaVO study operations and the arts, the University is obliged to collect, store and, if necessary, transfer certain data to the competent authority for the purpose of tracing possible infection paths of those present.

Without providing your contact details, we cannot allow you to participate in an on-site event or other activities or to visit or use facilities at the University of Freiburg. You are also obliged to provide accurate information.

A renewed collection of your contact data is not necessary if the data is already available. This is the case, for example, if you have entered your current address and telephone number into HISinOne. Note:

According to § 14 in conjunction with § 7 of CoronaVO a **ban on entry and participation** applies to people who

- have been in contact with a person infected with coronavirus within the past 14 days,
- show typical symptoms of a coronavirus infection, such as fever, dry cough, or an impaired sense of taste or smell or
- do not wear a mouth-and-nose covering.

This ban includes the entire University campus as well as all facilities, events and activities at the University of Freiburg. According to § 19 No. 5 CoronaVO, a violation constitutes an administrative offense that is punishable by fine.

<p>Your rights as a data subject:</p> <ul style="list-style-type: none">▪ You have the right to obtain information from the University of Freiburg about the data stored about you and/or to have incorrectly stored data corrected.▪ In addition, you have the right to have your data deleted or to restrict processing, as well as the right to object to processing.▪ You have the right to complain to a supervisory authority if you believe that the processing of personal data concerning you is in violation of legal provisions.
